Emergency Overview: Liquid is irritating to the skin and eyes and may be corrosive to the eyes. Fumes may be irritating when inhaled. Product is non-flammable, water based and presents little hazard in a fire. A tan liquid with a pleasant fragrance.

Section 4 - First Aid Measures

unconscious person. Treat for shock by keeping the person warm and quiet. Get medical attention at once. **Inhalation:** If affected, move person to fresh air. If irritation persists get medical attention.

In laboratory rats 2-Hydroxyethyl Amine has been suggested as a cause of kidney abnormalities. Exposure to this ingredient was tested by personal air monitoring following NIOSH methods. This was done in an average sized grocery store during a 7 hour period of stripping. The highest 8 hour TWA for a test subject was below the limits shown in Section 8 above.
